STIPULATION AND AGREED ORDER

1. The Parties appeared before the Honorable Celia G. Gamrath on December 3, 2019, for a status following Plaintiffs' submission of their Motion for Class Certification.
2. At the status, the Court issued an order in which it required Defendants to conduct class discovery on or before March 6, 2020, and to file their Opposition to Class Certification on or before April 17, 2020.
3. Over the last several months, Defendants have been working in good faith to prepare for, schedule, and conduct the necessary depositions prior to filing their Opposition. Nonetheless, Defendants require additional time to finish class discovery and file their Opposition.
4. In addition, Plaintiffs have sought a number of depositions from Defendants during this class discovery period, which Defendants have agreed to accommodate.
5. Accordingly, the Parties have agreed, subject to the Court's approval:
 - a. to extend the time for Defendants to conduct class discovery and to file their Opposition to Class Certification until May 12, 2020;

- b. to submit a further briefing schedule for Plaintiffs to file their Reply in support of their Motion for Class Certification within 10 days after Defendants file their Opposition to Class Certification; and
 - c. to strike the status set for April 29, 2020.
6. In accordance with the Parties' agreement, it is therefore ORDERED that:
- a. The deadlines for Defendants to conduct class discovery and respond to Plaintiffs' Motion for Class Certification are stricken and reset to May 12, 2020;
 - b. The parties shall submit a further briefing schedule for Plaintiffs to file their Reply in support of their Motion for Class Certification within 10 days after Defendants file their Opposition to Class Certification;
 - c. The status date of April 29, 2020, at 1:00 p.m. is stricken.
