STIPULATION AND AGREED ORDER

1. On March 11, 2020, this Court entered an Agreed Order, which, among other things, set the deadlines for Defendants to conduct class discovery and respond to Plaintiffs' Motion for Class Certification for May 12, 2020.
2. At the time the Court entered the Agreed Order, the Parties had agreed to dates for nine oral depositions to be conducted in the two-month period between March 11, 2020, and May 12, 2020.
3. As a result of the COVID-19 pandemic and Governor Pritzker's March 20, 2020 Executive Order requiring that Illinois citizens shelter in place, the Parties determined to adjourn the depositions and agreed to re-schedule them at a date to be later determined.
4. The Parties are working together to explore alternative dates for the depositions to be conducted. At this time, however, the depositions required for Defendants to respond to Plaintiffs' Motion for Class Certification have not been completed.
5. Accordingly, the Parties have agreed, subject to the Court's approval, to strike the May 12, 2020 deadline for Defendants to complete class discovery and to file their Opposition to

Class Certification, and to submit a further Agreed Order on or before June 30, 2020, in which the Parties will propose new dates to the Court.

6. In accordance with the Parties' agreement, it is therefore ORDERED that:
 - a. The May 12, 2020 deadline for Defendants to conduct class discovery and respond to Plaintiffs' Motion for Class Certification are stricken and reset to date to be determined;
 - b. The parties shall submit to the Court no later than June 30, 2020, a further proposed Agreed Order setting new deadlines for Defendants to conduct class discovery and respond to Plaintiffs' Motion for Class Certification.
