ORDER

This cause came to be heard on the Plaintiffs' Unopposed Motion for Approval of Class Notice Plan, the Court has reviewed the revised Longform Class Notice submitted by the Plaintiffs on June 2, 2022, as well as the Publication Notice submitted by the Plaintiffs on May 26, 2022. The form of the Longform Class Notice submitted on June 2, 2022 is approved, except that Plaintiffs are directed to include as one of the factors the Court may consider in determining whether an opt out request by a later transferee, assignee, heir or successor is timely and proper (as reflected, for example, in pages 6 and 9, questions #3 and #10) consideration of whether it would cause prejudice to the rights of the parties, the Classes, or any other relevant stakeholders. The form of the Publication Notice submitted on May 26, 2022 is approved.

IT IS THEREFOR ORDERED:

1. Plaintiffs shall proceed to file the further revised, final Longform Class Notice today, June 3, 2022.
2. Plaintiffs shall provide the firm that will disseminate the notices copies of the revised, final Longform Class Notice and of the Publication Notice approved by the Court today, June 3, 2022.
3. Plaintiff shall cause the revised, final Longform Class Notice and the Publication Notice to be disseminated as described in the forms approved by the Court.
4. The hearing previously set for June 3, 2022, at 2:00 pm CT is hereby STRICKEN.
5. The parties shall provide the Court with a written status report on or before August 31, 2022, at which time they may request a Court status date.
