
2. Following further discussion, the parties have agreed, subject to the Court's approval, to the following schedule:

February 10, 2023	Completion of fact discovery
February 24, 2023	Service of Plaintiffs' expert reports
March 24, 2023	Completion of Plaintiffs' expert depositions
April 14, 2023	Service of Defendants' affirmative expert reports (if any) and Defendants' rebuttal expert reports
May 12, 2023	Completion of Defendants' expert depositions
June 2, 2023	Service of Plaintiffs' rebuttal reports and reply reports in support of affirmative expert reports
June 30, 2023	Completion of Plaintiffs' rebuttal expert depositions
July 12, 2023	Service of Defendants' Reply expert reports (if any) in support of affirmative reports
July 21, 2023	Deadline for filing dispositive motions

3. In accordance with the Parties' agreement, it is therefore ORDERED that the following deadlines shall apply:

February 10, 2023	Completion of fact discovery
February 24, 2023	Service of Plaintiffs' expert reports
March 24, 2023	Completion of Plaintiffs' expert depositions
April 14, 2023	Service of Defendants' affirmative expert reports (if any) and Defendants' rebuttal expert reports
May 12, 2023	Completion of Defendants' expert depositions
June 2, 2023	Service of Plaintiffs' rebuttal reports and reply reports (if any) in support of affirmative expert reports
June 30, 2023	Completion of Plaintiffs' rebuttal expert depositions
July 12, 2023	Service of Defendants' Reply expert reports (if any) in support of affirmative reports
July 21, 2023	Deadline for filing dispositive motions
