STIPULATION AND AGREED ORDER

1. On June 1, 2023, the Court entered a scheduling order amending the deadlines for the completion of fact discovery, timing of expert reports and depositions, and filing of any dispositive motions.
2. Following the entry of the scheduling order, the parties determined that additional time was needed to complete their respective expert reports and depositions and that further modifications to the current pre-trial schedule would be necessary.
3. Plaintiffs served their expert reports on July 14, 2023, and Defendants completed Plaintiffs' expert depositions on September 13, 2023.
4. The parties are working diligently to complete the remainder of expert discovery and have agreed, subject to the Court's approval, to the following further amended schedule:

October 20, 2023	Service of Defendants' affirmative expert reports (if any) and Defendants' rebuttal expert reports
November 10, 2023	Completion of Defendants' expert depositions

November 21, 2023	Service of Plaintiffs' rebuttal reports and reply reports in support of affirmative expert reports
December 14, 2023	Completion of Plaintiffs' rebuttal expert depositions
December 22, 2023	Service of Defendants' Reply expert reports (if any) in support of affirmative reports
January 31, 2024	Deadline for filing dispositive motions

5. The parties further agree to continue to negotiate any additional schedule modifications in good faith to the extent any party becomes unable to meet the agreed-upon deadlines set forth in this amended schedule.

6. In accordance with the Parties' agreement, it is now ORDERED that:

(a) The previous deadlines set for (i) service of Defendants' affirmative expert reports (if any) and Defendants' rebuttal expert reports; (ii) completion of Defendants' expert depositions; (iii) service of Plaintiffs' rebuttal reports and reply reports in support of affirmative expert reports; (iv) completion of Plaintiffs' rebuttal expert depositions; (v) service of Defendants' Reply expert reports (if any) in support of affirmative reports; and (vi) filing of dispositive motions are hereby stricken;

(b) The following amended schedule and deadlines are adopted:

October 20, 2023	Service of Defendants' affirmative expert reports (if any) and Defendants' rebuttal expert reports
November 10, 2023	Completion of Defendants' expert depositions
November 21, 2023	Service of Plaintiffs' rebuttal reports and reply reports in support of affirmative expert reports
December 14, 2023	Completion of Plaintiffs' rebuttal expert depositions

December 22, 2023	Service of Defendants' Reply expert reports (if any) in support of affirmative reports
January 31, 2024	Deadline for filing dispositive motions

(c) A status conference to discuss case progress and dispositive motion.


