STIPULATION AND AGREED ORDER

1. On February 26, 2024, the Court entered an Agreed Order, which among other things, set the deadline for Plaintiffs' Oppositions to Defendants' Motions for Summary Judgment, to Decertify the Class, and to Exclude the Testimony of Jonathan Arnold for April 12, 2024.
2. In accordance with that Agreed Order, Plaintiffs served their Oppositions on Defendants on April 12, 2024.
3. On April 15, 2024, Plaintiffs filed with the Court their Oppositions to Defendants' Motion to Decertify the Class and Motion to Exclude the Testimony of Jonathan Arnold.
4. Plaintiffs' Opposition to Defendants' Motion for Summary Judgment references and attaches as exhibits a number of documents that Defendants designated as Confidential under the parties' Agreed Confidentiality Order dated November 2, 2015.
5. In order to allow Defendants an opportunity to review the designated materials and determine whether any require sealing and/or redaction prior to filing and to promote the

orderly sealing of appropriately designated materials, and, in accordance with Paragraph 10 of the Agreed Confidentiality Order and this Court's Standing Order, the Parties have agreed, subject to the Court's approval, upon the following procedures:

- (i) On or before April 19, 2024, Defendants will inform Plaintiffs of their position regarding the confidentiality of information contained in Plaintiffs' Opposition to Defendants' Motion for Summary Judgment or the exhibits attached thereto.
- (ii) In the event Defendants determine to waive all confidentiality designations, Plaintiffs will file their Opposition to Defendants' Motion for Summary Judgment and exhibits thereto on or before April 22, 2024.
- (iii) In the event Defendants determine that the sealing of any information is required, the Parties shall meet and confer regarding the confidentiality designations on or before April 23, 2024.
- (iv) If necessary, Defendants will file a motion to seal on or before April 24, 2024. At that time the parties will submit a proposed hearing schedule for the motion.
- (v) After the Court rules on any such motion, Plaintiffs will file a redacted and sealed unredacted copy of the Opposition to Defendants' Motion for Summary Judgment and the exhibits thereto.

6. In accordance with the Parties' agreement, it is now ORDERED that:

- (i) On or before April 19, 2024, Defendants shall inform Plaintiffs of their position regarding the confidentiality of information contained in Plaintiffs' Opposition to Defendants' Motion for Summary Judgment or the exhibits attached thereto.
- (ii) In the event Defendants determine to waive all confidentiality designations, Plaintiffs shall file their Opposition to Defendants' Motion for Summary Judgment and exhibits thereto on or before April 22, 2024.
- (iii) In the event Defendants determine that the sealing of any information is required, the Parties shall meet and confer regarding exhibit designations on or before April 23, 2024.
- (iv) If necessary, Defendants shall file a motion to seal on or before April 24, 2024. At that time the parties shall submit a proposed hearing schedule for the motion.


